MEMORANDUM

To: Chief of EMGFA

Subject: Report of cadets who are believed to have infiltrated the Military School

There is information from reliable sources that Mr. ENRIQUE SILVA, who resides at Colonia Utila, 6a, Calle Ote No. 7-4, Santa Tecla, Tel. 28-27-52, residence owned by ALFREDO BRACAMONTE, visits constantly three cadets of the Military School. One of the cadets is named GOMEZ DURAN, brother of MARIO ANTONIO DURAN, residing at Colonia Guadalupe Soyapango, Pasaje No. 23, House No. 1. The names of the other cadets are not known.

RECOMMENDATIONS

Observe the residence of Mr. ENRIQUE SILVA who, according to the information, is the contact of the cadets who await orders from the terrorists.

Have the school submit as soon as possible to this body the file of cadet GOMEZ DURAN.

That the S-II of this school initiate an investigation in order to check out who the other two cadets are who were seen visiting Mr. SILVA, and report immediately to this body.

- 1.- There is knowledge that the leadership of the FMLN has circulated instructions to its organizations operating in the departments of SAN VICENTE and USULUTAN, to use all their means to neutralize the work of those departments which is being developed by the Government through the NATIONAL COMMISSION OF REHABILITATION; letting them know that this work is being done with U.S. advice through the aid plan that country is extending to El Salvador.
- 2.- There is knowledge that the FMLN has circulated instructions to all the terrorist organizations under its leadership in regard to the change of offensive military tactic against the National Army, using the following offensive tactics:
  - a.- MOVEMENT WARFARE
  - b.- POSITION WARFARE
  - c.- INCURSION WARFARE.

For the development of these activities, they are performing constant movements from one place to another, as they establish attack positions over the

highways, where they concentrate on stealing light vehicles, especially pick-ups and minibuses, which are taken to nearby places, where groups of terrorists are concentrated, in order to perform additional movements to reach their own positions and or attack military bases, set up in order to protect vital objectives of the national economy.
