SUMMARY OF ACTIONS OF "CLANDESTINE ORGANIZATIONS" THAT OPERATE
IN THE COUNTRY AND OTHER IMPORTANT EVENTS COMMITTED BY
COMMON DELINQUENTS, DURING THE PERIOD OF 1972 TO 1977.

PROLOGUE

FROM THE BEGINNING, THE WORLD HAS LIVED WITH VIOLENCE AND TERRORISM. TERRORISM HAS MANY FORMS: DISORDERS, FIRES, AND BOMBS, BUT IN RECENT YEARS, THE NEW AND MORE PERSONAL TRAIT OF TERRORISM IS KIDNAPPING, POINTING OUT INNOCENT PEOPLE, ANYONE ON THE LISTS. IT IS THE BEHAVIOR OF THE INNOCENT WHICH MAKES THIS PHENOMENON SO FEARFUL AND EFFECTIVE, FROM THE TERRORISTS' POINT OF VIEW.

IN RECENT YEARS, ARGENTINA HAS BEEN DISTINGUISHED FOR THE KIDNAPPING OF AMERICAN EXECUTIVES. BUENOS AIRES (ARGENTINA) IS REFERRED TO AS THE KIDNAPPING CENTER OF THE WORLD. KIDNAPPING HAS BECOME THE FIRST ENTRANCE FOR POLITICAL EXTREMISTS IN THIS CITY. DURING THE PERIOD OF 1970 - 1973, TWENTY-FIVE COMPANIES IN ARGENTINA REPORTED HAVING PAID MILLIONS TO FREE 250 EXECUTIVES.

CATEGORY OF KIDNAPPINGS

THESE PLANNED KIDNAPPINGS KNOW THAT FEAR IS THE BEST WEAPON. ACCORDING TO A KNOWN POLITICAL FIGURE, THE FEAR CREATES TERROR, AND WITH TERROR COMES THE DESTRUCTION OF THE HUMAN SPIRIT AND THE LOSS OF DETERMINATION TO OPPOSE THE TERROR..... TERRORISTS. THE WORLD ALREADY KNOWS THIS. THEY ARE SPREADING FEAR WITH FREQUENT INCREMENTS OF MANIAC KNOWLEDGE AND THREATEN WITH VIOLENT ACTS UNLESS THEY ACCEPT THE DEMANDS. KIDNAPPING, A CLASSICAL ACT OF TERRORISM, HAS BEEN CLASSIFIED IN TWO CATEGORIES: POLITICAL AND CRIMINAL.

HOW SUBVERSION INITIATED WORLD MOBILIZATION

CLOSE TO THE ROOT OF WORLD MOBILIZATION AND PRIMARY TO IT, THE FOLLOWING ACTIVIST FRONTS WERE BORNE:

DERIVATION AND ORIGIN OF THE STAFFS OF URBAN AND RURAL GUERRILLAS

IT WAS DURING THE YEARS OF 67-68-69-70-71, EPOCH WHEN THE GOVERNMENT INTELLIGENCE SERVICES DETECTED THE PRESENCE OF GROUPS IN THE SALVADORIAN COMMUNIST YOUTH OR REVOLUTIONARY YOUTH, MEMBERS OF "A.R.S." (SALVADORIAN REVOLUTIONARY ACTION), LEAD BY INTERNATIONAL SUBVERSION AND BY COMRADES TO THE LIKENESS OF SALVADOR CAYETANO CARPIO, LUIS FELIPE VAQUERANO, GABRIEL GALLEGOS VALDES, MARIO FLORES MACALL, ROBERTO CASTELLANOS CALVO, SCHAFICK JORGE HANDALL, JOSE DOMINGO MIRA OLIVA, AUGUSTO ARISTIDES LARIN, JOSE MANUEL GAVIDIA, PEDRO MIGUEL MARMOL AND OTHERS ALREADY RECOGNIZED.

CREATION OF "LOS NONUALCOS" GUERRILLA GROUP

* THIS GUERRILLA GROUP WAS CREATED IN JANUARY 1970 AND ITS FIRST OR PRINCIPLE ORGANIZER WAS SALVADOR CAYETANO CARPIO, FOLLOWED BY JOSE DIMAS ALAS ALFARO, RAUL ANGEL MERLOS CALDERON AND FERNANDO SANCHEZ VASQUEZ. THIS STAFF INTENDED TO EXECUTE TERRORIST PLANS AND THE ASSASSINATION OF MILITARY LEADERS, SYNDICAL LEADERS OF DEMOCRATIC IDEOLOGY AND THE KIDNAPPING OF WEALTHY PEOPLE. ACCORDING TO INFORMATION, THESE PERSONS WERE EXPELLED FROM THE SALVADORIAN COMMUNIST PARTY, P.C.S. THEY INITIATED THEIR WORK BY COLLECTING ADDRESSES OF THE VICTIMS TO ASSASSINATE OR KIDNAP THEM, AS COMMUNIST WAR PROCESS.

ANOTHER GUERRILLA FACTION AND ITS FIRST MANUVERE.

** IN 1970, ANOTHER STUDENT GROUP SURGES WHICH WAS NEVER GIVEN A NAME. INCLUDED IN ITS RANKS WAS COSTA RICAN MERCENARY JOSE EDUARDO SANCHO CASTANEDA, WHO ALONG WITH ALEJANDRO RIVAS MIRA, CARLOS ALBERTO MENJIVAR MARTINEZ, RICARDO SOL ARRIAZA, SALVADOR ORLANDO MONTOYA MENJIVAR, JORGE RAFAEL CACERES PRENDES, LUISA EUGENIA CASTILLO MARTINEZ (WIFE OF SOL ARRIAZA) AND MARIA DE LOS ANGELES LINARES OLIVO DE MENJIVAR (WIFE OF MENJIVAR MARTINEZ) BELONGED TO THE CHRISTIAN DEMOCRATS.

HISTORY OF "LOS TIGRES" GUERRILLA GROUP.

IN 1970, RECOGNIZED POLITICAL AND COMMUNIST LEADERS POLITICIZED, MADE AWARE AND INDOCTRINATED THE WOMB OF THE MASSES OF THE PEOPLE, ORGANIZING THE FIRST GROUP WITH REVOLUTIONARY AND COMBATIVE CONSCIENCE, INTEGRATED BY THE MEMBERS OF THE CHRISTIAN DEMOCRATIC YOUTH AND THE SALVADORIAN COMMUNIST PARTY; VARIOUS NATIONAL TERRITORY LOCATIONS WERE KNOWN TO BE TRAINING CAMPS, MAINLY IN THE OPICO AND COMASAGUA ZONE IN THE DEPARTMENT OF LA LIBERTAD; SUCHITOTO AND COJUTEPEQUE IN THE CUSCATLAN DEPARTMENT.

FORMATION OF CLANDESTINELY OPERATING SUBVERSIVE ORGANIZATION.

P.R.S.-E.R.P.-(SALVADORIAN REVOLUTIONARY PARTY - REVOLUTIONARY ARMY OF THE PEOPLE).-

O.R.T. (REVOLUTIONARY ORGANIZATION OF WORKERS).

ANALYSIS OF THE BIRTH OF P.R.S. - ERP. IN EL SALVADOR*

IN 1972; THE MAIN AGGLUTINATING ELEMENT OF THAT TIME WAS IN THE CONSCIOUSNESS OF THE NEED TO ORGANIZE OR IMPEL THE ARMED BATTLE AS A ROUTE TO TAKE POWER. THE POLITICAL PRACTICE OF THOSE WHO WOULD FORM THE ERP. HAD DEMONSTRATED THAT THE TRADITIONAL ORGANIC STRUCTURES (COMMUNIST PARTY, SYNDICAL ORGANIZATIONS, NATIONAL AND STUDENT POLITICAL ORGANIZATIONS, UNIONS AND ORGANIZATIONS OF THE MASSES, ETC.), DUE TO THEIR CONCEPTION AND ORGANIC STRUCTURE, CONSTITUTED REAL OBJECTIVE AND SUBJECTIVE IMPEDIMENTS SO THAT FROM ITS WOMB THE MILITARY PRACTICE MIXED WITH A POLITICAL PRACTICE WOULD ARRISE. OVER ALL, THE DEVIATION TO THE RIGHT IN THE PARTY HAD REACHED THE STATE OF DEGENERATING THE ARMED BATTLE AS A ROUTE TO THE TAKING OF POWER TO A PEACEFUL ROUTE, THE ELECTORAL ROUTE. AS A RESULT OF THIS SITUATION, THE NEWLY BORN ORGANIZATIONS, AFFIRMED THE NEED TO CONSTRUCT THE ARMED APPARATUS, IMPELLING THE WAR ACTIVITY, DENYING THE PARTY. THAT IS HOW, IN 1971 AND 1972, A MILITARY CONCEPTION PREDOMINATES IN THE NEW ORGANIZATIONS, NOT ONLY IN ITS ORGANIZATIONAL AND CLANDESTINE ASPECTS, BUT IN ITS ARGUMENTS AND DEFENSE OF THE ARMED BATTLE.

THE ROOT OF THIS ERRONEOUS CONCEPTION RESIDES IN THE FOLLOWING ARGUMENT: IT IS NECESSARY TO DENY THE ORGANIC AND POLITICAL CONCEPTION OF THE P.C., ITS DEVIATION TO THE RIGHT; ONLY THEN CAN THE ARMED APPARATUS WHICH WAS ALWAYS DENIED IN PRACTICE CAN BE CONSTRUCTED.

THIS MECHANICAL ANALYSIS WORKED UNILATERALLY FOR TWO YEARS, CONSTRUCTING THE ARMED APPARATUS FOR THE REVOLUTIONARY PROCESS.

NOT BEING AWARE THAT BY DENYING A PARTY THAT HAD NOT CREATED THE MARXIST-LENINIST QUALITY, ALSO DENIES THE FORMATION FOR THE NEED TO CONSTRUCT FROM THE BEGINNING POLITICAL NECLEI: THUS, NOT FALLING INTO A UNILATERAL LEFTIST DEVIATION. THE ORGANIC WORK DIRECTED TO CONSTRUCT MILITARY NUCLEI, FUNDAMENTALLY DETERMINED THE DEVELOPMENT OR LIFE OF THE ERP.

THE FOUNDERS COMMITTED THE ERROR OF ORGANIC DEVELOPMENT IN ONLY ONE DIRECTION: MILITARY CONSTRUCTION, ABANDONING THE CONSTRUCTION OF THE POLITICAL TERRAIN IN THE WOMB OF THE MASSES AND THE E.R.P.

IN 1974, SIGNIFICANT FOR THE ERP., THE ALMOST DEFINITE REFINERY OF ITS STRATEGIC CONCEPTION AND POLITICAL LINE ON A DECLARATIVE THEORETIC LEVEL, THEY ALL APPEARED TO COINCIDE THAT THE STRATEGIC DUTY FOR THE ORGANIZATION WAS LOCATED, ON ONE HAND, IN CONSTRUCTING THE VANGUARD PARTY AND SEEK THE FORMS AND METHODS OF MIXING THEM TO THE MASSES TO UNIT THE CONDUCTION OF THE POPULAR BATTLE AND ORIENTATE THEM THROUGH THE REVOLUTIONARY CAUSES: ON THE OTHER HAND, CONSTRUCTING THE REVOLUTIONARY ARMY OF THE PEOPLE, AS WELL AS REFINING THE MILITARY CONCEPTION THROUGH WHICH AND UNDER THE GUIDANCE OF THE PARTY, POSSIBLY INCORPORATE THE MASSES IN THE ARMED ROUTE, TO THE TAKING OF POWER.

STRUCTURIZATION OF THE P.R.S.- E.R.P. ORGANIZATION.

- 1- THE PRS. OF THE POLITICAL LINE: ORGANIZATION; ARMED ACTIVITY
- 2- POLITICAL BUREAU: (VARIOUS) MOST CONTROLLED ORGANIZATIONS, ALTHOUGH SMALLER IN NUMBER.
- 3- NATIONAL DIRECTORSHIP (VARIOUS) THE RELATION BETWEEN BOTH ORGANIZATIONS SPECIFICALLY IS NOT SUPERIOR TO THE BUREAU, ALTHOUGH MORE AUTHORITY IS RECOGNIZED, BUT THERE ARE DECISIONS THAT THE DIRECTORSHIP CANNOT MAKE WITHOUT THE APPROVAL OF THE SAID BUREAU, THAT IS, THE AUTHORITY IS SPREAD OUT, LATHOUGH SUBORDINATION IS NOT FULLY RECOGNIZED.
- 4- THE NATIONAL DIRECTORSHIP.- THE RELATIONS BETWEEN BOTH ORGANIZATIONS IS WELL ESTABLISHED. IN THE CENTRAL COMMITTEE, THERE ARE COMMISSIONS WITH DIVERSE DUTIES, BUT MORE GENERAL AFFAIRS. IN THE CONGRESS (WHICH IS PROJECTED TO BE IN 1976) THE CENTRAL COMMITTEE WAS TO BE DETERMINED, WHICH WAS GOING TO PREFORM OR LEGALIZE THE GENERAL ASSEMBLY OF THE E.R.P.
- 5- REGIONAL COMMITTEES: 1) EASTERN ZONE; 2) CENTRAL ZONE; 3) WESTERN ZONE. THE DUTY IS ACCORDING TO JURISDICTIONS.
- 6- THE MAXIMUM ORGANIZATION IS THE "PLENO" [FULL(?)]. THIS IS THE ORGANIZATION WITH MAXIMUM AUTHORITY IN THE PARTY. IT IS MORE AMPLE AND HAS MORE AUTHORITY AND IS COMPOSED OF REPRESENTATIVES OF THE POLITICAL BUREAU, NATIONAL DIRECTORSHIP AND OF THE THREE REGIONAL COMMITTEES. THE SUBVERSIVE STAFFS DO NOT MAKE GEOGRAPHICAL PLANS, THEY SHARE THE ZONAL AND REGIONAL, ACCORDING TO THE POLITICAL AND COGNIZANT RESULTS. FOR EXAMPLE: THE ZONES CAN BE A COLONY OR DEPARTMENT; THE REGIONS CAN BE, FOR EXAMPLE: ALL THE TOWNS NORTH OF SAN SALVADOR.
- 7- DIRECTION BLOCKS: THESE ARE DEPENDANT ON THE REGIONAL COMMITTEES AND ARE COMPOSED OF THREE OR FOUR MEMBERS WITH JURISDICTION IN VARIOUS ZONES IN A REGION. THEY DISCUSS, CONDUCT AND DECIDE: THEY ARE THREE RIGHTS THAT TOGETHER COMPLEMENT THE ACTIVITY OF A BLOCK, BUT DUE TO DISCIPLINARY AFFAIRS, 1, 2 OR CAN BE SUSPENDED, OR COMPLETE SUSPENSION FOR DETERMINED AMOUNT OF TIME.

- 8- TRIAL BLOCKS: THEY CONSIST OF THREE OR FOUR MEMBERS. THEY HAVE PASSED THE STAGE OF BEING FORMATION BLOCKS, ALTHOUGH THEY STILL NEED SUPERVISION OF THE THREE ASPECTS. THEY ARE NOT DIRECT DIRECTION BLOCKS; THE MEMBERS ARE INDIVIDUALLY ASSESSMENT NOT THE BLOCK. THE CASE MAY BE THAT SOME ASSESSMENT, OTHERS REMAIN AT THE SAME LEVEL AND OTHERS DESCEND. AS THEY DESCEND, THEY RECEIVE LESS INFORMATION AND DO NOT DEAL WITH MORE SECRET AFFAIRS.
- 9- FORMATION BLOCKS: IN GENERAL TERMS, THEY ARE THE NEWEST PEOPLE JOINING THE PARTY, ALTHOUGH THERE COULD BE PERSONS THAT DESCENDED, EVEN THOUGH THEY REMAIN AT THAT LEVEL.
- 10- ALL OF THE MEMBERS OF THE ERP. ARE MEMBERS OF THE PRS., ALTHOUGH THEY DO NOT HAVE NECESSARILY THE SAME RANK OF IMPORTANCE.

THE STAFF ASSEMBLY OF THE ERP. IS SUBORDINATE TO THE POLITICAL BUREAU

MILITARY COMMITTEES: THESE ARE NOT PARTY ORGANIZATIONS, BUT THAT OF THE ERP. THE DEGREE OF DEMANDS FOR THE MILITARY COMMITTEES IS LESS DIFFERENT DISCIPLINE, BECAUSE THEY ARE DIFFERENT TYPES OF PEOPLE COMPOSING THEM. SOME WAY BECOME MEMBERS OF THE BLOCKS.

FORMATION OF THE ARMED FORCES OF THE NATIONAL RESISTANCE - F A R N.

IN MAY 1975, THE ARMED FORCES OF THE NATIONAL RESISTANCE "F A R N." IS FORMED WITH ITS "RN" LEADERSHIP COMMAND: AFTERWARDS, THIS CLANDESTINE ORGANIZATION FORMS THE REVOLUTIONARY ORIENTATION COMMITTEE - C.O.O.R., BEING FORCED TO DIVIDE WITH THE ERP., ALWAYS FOLLOWING THE PRS. POLITICAL LINE, DUE TO INTERNAL PROBLEMS. THEY PURGED SOME OF THEIR PRINCIPLE LEADERS, SUCH AS ROQUE DALTON GARCIA - SERGEANT PANCHITO, AND AS A RESULT OF THIS PURGING, THE NATIONAL RESISTANCE (R.N.) IS FORMED. THIS DECISION IS DUE TO THE NON-ACCEPTANCE OF THE PROPOSALS THAT ROQUE DALTON GARCIA BROUGHT FROM CUBA, WHICH THE ERP. DID NOT ACCEPT.

ON THE SUPERIOR ORGANIZATIONS LEVEL, THE FORMATION SCHOOL COMMISSIONS AND THE COMMISSION ON THE FRONT OF THE MASSES HAVE NOT BEEN STRUCTURED.

THE STRUCTURE FROM THE VANGUARD BLOCKS IS REPETATIVE IN EACH WORK ZONE OR SECTOR OF THE ORGANIZATION; POSSIBLY, SOME HAVE ACHIEVED THE DEGREE OF CONSOLIDATION WHICH PERMITS THEM TO HAVE CREATED ALL OF THE ORGANIC LEVELS, AS WELL AS THE CREATION OR THE FUNCTIONING OF THE SPECIAL COMMISSIONS THAT REPEAT TO SOME DEGREE THE COMMISSION SCHEMES ON A CENTRAL LEVEL AND ARE UNITED WITH THEM FOR WORK COORDINATION.

COMPOSITION AND FUNCTIONING OF THE F.A.R.N.

- NATIONAL MILITARY COMMISSION

THE NATIONAL MILITARY COMMISSION IS SUBORDINATE TO THE NATIONAL DIRECTORSHIP. THE WORK SHOP AND INFORMATION WRITINGS ARE BEING CONSTRUCTED. LIKEWISE, THERE IS A PROJECT OF INTEGRATING THE ORGANIZATIONS THAT WILL FORM THE MILITARY INSTRUCTORS SCHOOL.

THE MILITARY SUB-COMMISSIONS HAVE BECOME FUNCTIONAL. THEY STILL DO NOT WORK ON A TOTALLY COMPARTMENTED FORM CONCERNING THE ZONES OR SECTORS. VARIOUS REPRESENTATIVES IN THE ZONES FORM A WORK SUB-COMMISSION ALONG WITH ONE OF THE MEMBERS OF THE NATIONAL MILITARY COMMISSION. THE PURPOSE IS TO CREATE A SUB-COMMISSION FOR EACH WORK ZONE, AND IN THE FUTURE, DEFINITELY STRUCTURE THE NATIONAL MILITARY COMMISSION, WHICH, LIKE THE CURRENT NATIONAL DIRECTORSHIP, IS PROVISIONAL.

AFTER ONE YEAR, THE AFOREMENTIONED STRUCTURE OF THE "R.N.", ON THE BASIS OF THE DESERTION OF SOME OF ITS LEADER WHO TEMPORARILY OR DEFINITELY ANANDONED THE RANKS (WHO ?), CAUSED CERTAIN DETERIORATION, BUT THE ACCEPTANCE IT HAS HAD IN THE HIGHER EDUCATION CENTERS IS CONFIRMED; IF WE COMPARE THE MENTIONED DATA.

WHO WAS AGUSTIN FARABUNDO MARTI.

"THE REBLE".

AGUSTIN FARABUNDO MARTI, WAS A REVOLUTIONARY PROLETARIAT, ESTABLISHED MARXIST-LENINIST, WHO FOUGHT FOR THE CAUSE OF THE PEOPLE AND DIED DEFENDING IT BEFORE A FIRING SQUAD IN 1932.

HIS NAME IS INTIMATELY ASSOCIATED WITH THE GREAT WORKER-FARMER INSURRECTION OF FEBRUARY 21, 1932, FOR BEING THE HIGHEST LEADER; ALTHOUGH HIS CAPTURE AND INPRISONMENT WERE PREMATURE, WHICH WAS PREFORMED BY THE REPRESSIVE CRIMINAL FORCES. DIRECTED BY THE BLOOD-THIRSTY GENERAL MARTINEZ, WHO DID NOT PERMIT HIM TO BE PRESENT FOR ITS EXPLOSION.

FARABUNDO MARTI WAS BORN IN TEOTEPEQUE IN 1883. HIS FATHER WAS THE OWNER OF LARGE AMOUNTS OF LAND IN THE DEPARTMENT OF LA LIBERTAD, AND IT WAS HERE, IN THE COUNTRY ENVIRONMENT WHERE HE GREW UP WITH HIS NINE BROTHERS. AT AN EARLY AGE, HE KNEW THE EXPLOITATION THE COUNTRYMEN AND LABOURERS SUFFERED AND EXPERIENCES THE MANIFEST SOCIAL INEQUALITY REFLECTED BETWEEN HIM AND HIS BROTHERS, SONS OF THE BOSS, WELL CLAD AND THE CHILDREN OF THE LABOURERS, TATTERED AND WITHOUT BREAD.

AS HE GREW, HIS FATHER ENROLLED HIM IN RELIGIOUS SCHOOLS. LATER, HE ENTERED THE UNIVERSITY OF EL SALVADOR AND INCLINED TOWARDS A JURISPRUDENCE CAREER AND CC. SS. [T/R NOTE: COOPERATIVE COLLEGE-SCHOOL SCIENCE (PROGRAM)] (1916-1919). THIS WAS THE START OF HIS GREAT POLITICAL TRAJECTORY, SINCE IT WAS A PERIOD OF KNOWLEDGE AND STUDY OF THE MARXIST THEORY AND POLITICAL HABITUATION AS STUDENT LEADER.

DURING THIS PERIOD, A SITUATION OCCURS WHICH CHANGES THE LIFE OF FARABUNDO MARTI. IN A POPULAR MEETING, THE UNIVERSITY STUDENTS THE "MELENDEZ" REGIME AS DOCTOR JORGE MELENDEZ TOOK THE POSITION OF PRESIDENT: THE POLICE FIERCEFULLY CLASHES WITH THE UNARMED CROWD AND CAPTURES SOME OF THE PROTESTERS, INCLUDING LEADER LUIS BARRIENTOS AND FARABUNDO MARTI.

THE PROTESTS OF THE PEOPLE FORCES MELENDEZ TO FREE THE DETAINED, EXCEPT BARRIENTOS. MARTI, IN AN ACT OF SOLIDARITY WITH HIS COMPANION DOES NOT LEAVE THE JAIL AND BOTH OF THEM WERE IMMEDIATELY EXILED TO GUATEMALA; THE EXILE LASTED 5 YEARS.

THIS EVENT TERMINATES THE STUDENT LIFE OF FARABUNDO MARTI, WHO DEDICATES HIMSELF ENTIRELY TO THE PROLETARIAN CAUSE.

DURING THE EXILE, MARTI SUFFERED A RAPID PROLETARIAN PROCESS; HE WORKED DIVERSE JOBS, IN AGRICULTURE AS WELL AS URBAN AND HE EXPERIENCED THE MERCILESS EXPLOITATION SUFFERED BY THE LABORERS FOR HIMSELF. DURING THIS PERIOD FROM 1920 TO 1925, LARGE SCALE POLITICAL EVENTS OCCUR IN EL SALVADOR IN AGREEMENT WITH THE POLITICAL AND SOCIAL SCENE OF THAT TIME AND WHICH ARE IMPORTANT ANTECEDENTS OF THE INSURRECTION OF 1932. IN 1923, THE POLITICALLY CORRUPT ALFONSO QUINONEZ MILINA, INTIMATELY ASSOCIATED WITH THE MELENDEZ AND THE OLIGARCHY, TAKES POWER AND IS SUPPORTED BY THE "LIGA ROJA" ["RED LEAGUE"] GOVERNMENTAL-POLITICAL ORGANIZATION THROUGH PETULANT FRAUDE AGAINST DOCTOR MIGUEL QUINONEZ MOLINA.

ALSO, THE ZONE LEADERS (COORDINATORS) AND OF THESE THE CENTRAL, WESTERN AND EASTERN ZONES ARE DEPENDENT OF THE CENTRAL COMMAND. THE ZONE LEADERS ARE IN CHARGE OF POLITIZATION, INDOCTRINATION AND PREPARING THE OPERATIONAL STAFFS.

THE POLITICAL AND MILITARY STRUCTURE OF THE F.P.L. HAS HUMAN ELEMENTS INTEGRATED BY: PROFESSIONALS, STUDENTS, PROFESSORS, URBAN AND RURAL WORKERS. THERE WERE TWO VEHICLES, ONE SKY BLUE CHEVY AND A SKY BLUE MAZDA PICK-UP WITH RAILINGS AND CANVAS. THAT IS, THE OPERATION WAS DECIDED UPON FROM FRIDAY TO SATURDAY NIGHT, TO BE PERFORMED SUNDAY MORNING. THEY LATER SAID THAT THE OPERATION HAD BEEN SUSPENDED. THE NEXT MONDAY THEY SAID; I DO NOT REMEMBER IF AMILCAR (RAFAEL ANTONIO ARCE ZABLAH) OR GUILLERMO (JOAQUIN VILLALOBOS HUEZO) TOLD ME

TO GO TO SAN MIGUEL AND THEN TO SANTA ROSA DE LIMA; I WAS TO SEE BALTA IN THE AFTERNOON TO FIND OUT IF A SO CALLED CARMELO (A.K.A.) SENT A MESSAGE TO AMILCAR.

BALTA WAS IN SAN SALVADOR SINCE SUNDAY AND HE TOLD US TO LEAVE WITHOUT WEAPONS AND WITHOUT PROPAGANDA, BECAUSE HE SAID IT WAS SURE TO HAVE STARTED BY THAT TIME. I DO NOT REMEMBER IF JOSEFINA WAS THERE. WE LEFT WITH BALTA TO SAN MIGUEL AND HE CONTINUED TO SANTA ROSA DE LIMA, WHILE I WENT TO THE HOUSE I KNEW IN SAN MIGUEL. LISTENING TO THE RADIO I LEARNED OF THE NEWS OF THE KIDNAPPING OF MISTER FRANCISCO DE SOLA, WHICH SURPRISED ME, BECAUSE I DID NOT BELIEVE THEY COULD MOUNT AN OPERATION THAT THAT, BECAUSE THEY HAD LEAD ME TO BELIEVE THAT IT WAS VERY DELICATE AND I THOUGHT IT WAS BEYOND THE CAPACITY OF THE ORGANIZATION. I TOLD BALTA IN THE AFTERNOON WHEN I SAW HIM IN SANTA ROSA DE LIMA, HE WAS ALSO SURPRISED; WE SPECULATED ON THE AMOUNT THEY WOULD ASK FOR A RANSOM.

I RETURNED TO SAN SALVADOR; IN THOSE DAYS, THERE WERE NO BLOCK MEETINGS AND I REMAINED AT HOME. ALSO, CHELE LUIS ARRIVED THERE (IT WAS THE HOUSE AT LAS FLORES COLONY, SOYAPANGO). GUILLERMO ARRIVED FROM TIME TO TIME: I ASKED HIM HOW MUCH WAS GOING TO BE ASKED AND HE SAID ONLY TWO MILLION COLONS SO THEY COULD RAPIDLY GATHER THE MONEY AND WE WOULD NOT WASTE TO MUCH TIME AND GET OUT OF THE SITUATION. ALONE HE WAS VERY DIFFERENT AND WAS COMPLETELY DIFFERENT FROM ESCOBAR VIDES; HE DID NOT CRY AND WAS NOT ARGUMENTATIVE; HE SAID HE WAS SURE HIS FAMILY WOULD PAY THE RANSOM AND THAT WHAT HAD HAPPENED WITH TOMAS REGALADO, WHO DID NOT GIVE UP MONEY FOR HIS BROTHER ERNESTO, WOULD NOT HAPPEN TO HIM.

THE PAYMENT OF THE RANSOM WAS DONE ON A SATURDAY OR SUNDAY; I INDIRECTLY FOUND OUT BECAUSE CHELE LUIS PARTICIPATED, AT LEAST AS PART OF THE SECURITY TEAM.

WHEN THEY ATTACKED THE "ANTEL" OFFICE, TWO MEN AND A WOMEN ARRIVED AND TOLD THE TELEGRAPH OPERATOR, MISTER RAFAEL ANTONIO REYES AND MESSENGER ROSMER ALBERTO PORTILLO NOT TO MAKE NOISE AND TOLD THEM TO LAY RIGHT-SIDE UP; AS SOON AS THEY ENTERED THE OFFICE THEY CUT THE ELECTRIC LIGHT WIRES. THEY PAINTED THE FOLLOWING ON THE ENTRANCE DOOR OF THE OFFICE: REVOLUTIONARY ARMY OF THE PEOPLE-ERP.-

WHEN THEY ATTACKED THE COMMAND POST OF THE NATIONAL GUARD, THEY IMMEDIATELY KILLED GUARDSMAN ROBERTO DE JESUS REYES CAMPOS, BADGE NO. 842., WHO WAS GUARDING THE DOOR; INSIDE THE OFFICE, THEY KILLED GUARDSMAN JOSE CRISTOBAL CORTEZ, BADGE NO. 543. AFTER KILLING THEM, THE INDIVIDUALS TOOK THE THREE EQUIPMENT RIFLES, AMMUNITION, THE THREE FIBRE HELMETS, UNIFORMS, ONE PISTOL FROM CORPORAL CALLES AND SEARCHED THE LUGGAGE OF ALL OF THE PERSONNEL. MINOR OSCAR ARMANDO ARGUETA PALMA, ASSISTANT OF AFOREMENTIONED PERSONNEL, RECEIVED AN INJURY ON THE RIGHT FOOT FROM A WEAPON, AND WAS TAKEN TO THE HOSPITAL AT LA UNION.

GUARDSMEN CARLOS FUENTES ARANIVAL, BADGE NO. 817, AND RECARDO ANTONIO ANDRADE, BADGE NUMBER 313, HAD GONE ON PATROL, AT THE TIME OF THE ATTACK THEY ARRIVED AT THE TOWN; WHEN THEY NOTICED THE EVENTS, THEY TOOK THE NECESSARY MEASURES, AND UPON NEARING THE POST, THE GUERILLAS HAD NOT LEFT AND THAT IS WHEN BOTH BANDS OR FORCES CONFRONTED EACH OTHER.

TO LEAVE SAID TOWN, THE GUERILLAS USED A PICK-UP, LICENSE PLATE 83-190 NOTED IN THE FOLLOWING REPORT: IT IS KNOWN TO THIS COMMAND THAT AT 1300 HOURS ON THIS DATE (SEPTEMBER 19), MISTER JORGE GIRONES SABATER ARRIVED, RESIDENT OF GENOVA STREET NO. 386, MIRALVALLE COLONY OF THIS CITY, WHO STATED THAT ON THE 18 OF THE CURRENT, AT 0915 HOURS, AT 73RD AVENUE NORTH AND ITS MANIA PASSAGE OF THE ESCALON COLONY OF THIS LOCALITY, FOUR YOUNG INDIVIDUALS BETWEEN 19 AND 25 YEARS OF AGE, DETAINED HIM AS HE DROVE HIS WHITE FORD CURIER PICK-UP, LICENSE PLATE 83-190, POINTED HIM WITH A 45 PISTOL AND TOOK HIM AND HIS VEHICLE.
