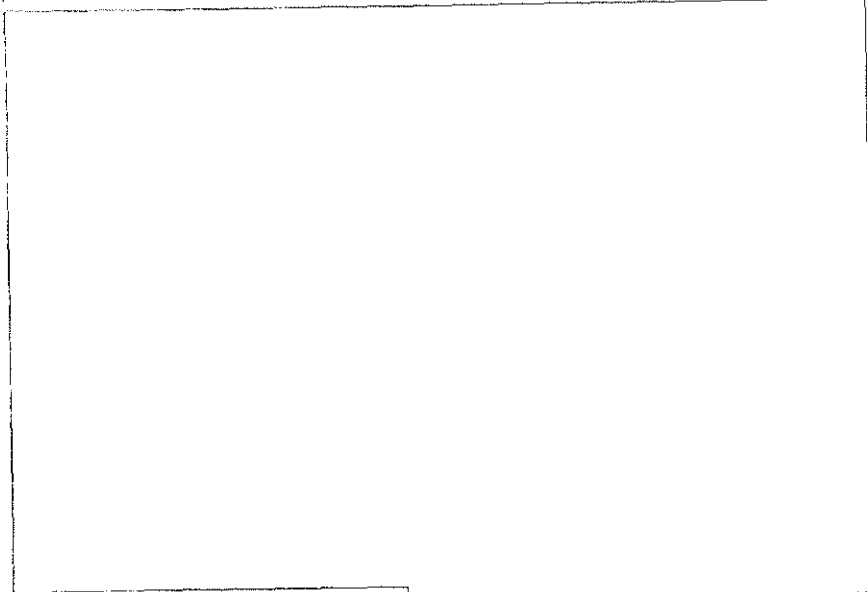

4. [REDACTED] THE PDC LEADERSHIP CONTINUES TO BE CONCERNED OVER COLONEL JUAN RAFAEL ((BUSTILLO)), COMMANDER OF THE AIR FORCE. HE SAID BUSTILLO RECENTLY ASKED PRESIDENT DUARTE FOR CONCURRENCE TO BRING BACK TO EL SALVADOR COLONEL SIGIFREDO ((OCHOA)) PEREZ, CURRENTLY SERVING IN WASHINGTON, D.C. THE LEADER INDICATED THAT THE REQUEST WAS IN CONNECTION WITH A COMMAND ASSIGNMENT FOR OCHOA. [REDACTED] THE PDC LEADERSHIP WAS ASTONISHED AT THE REQUEST AND THAT THE ARMY SHOULD HAVE KNOWN THAT OCHOA WAS POLITICALLY UNACCEPTABLE TO THE PDC. PRESIDENT DUARTE REJECTED THE REQUEST.
