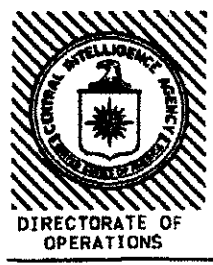

TEXT: 1. GENERAL JOSE GUILLERMO ((GARCIA)), MINISTER OF
DEFENSE, AND COL. RAFAEL ((FLORES)) LIMA, CHIEF OF THE ARMED
FORCES GENERAL STAFF, CONTINUE TO MEET REGULARLY WITH KEY
FIELD COMMANDERS TO SEEK A SOLUTION TO THE REBELLION OF
LTC. SIGIFREDD ((OCHOA)) PEREZ, COMMANDER OF MILITARY DETACHMENT 2,
WHO REMAINS IN CABANAS DEPARTMENT AND INSISTS ON GARCIA'S
RESIGNATION. HOWEVER, BOTH GARCIA AND OCHOA ARE BECOMING MORE
FLEXIBLE AND IT IS LIKELY THAT A PEACEFUL RESOLUTION OF THE
CONFLICT WILL RESULT.

2. GARCIA HAS CONFIDED THAT, IF OCHOA CONCEDES AND
ACCEPTS AN OVERSEAS ASSIGNMENT, HE IS WILLING TO RETIRE FROM
THE ARMY, PERHAPS TWO TO THREE MONTHS LATER. FLORES LIMA HAS
PRIVATELY ADVISED GARCIA THAT, IF THE LEVEL OF OPPOSITION AGAINST HIM
CONTINUES, HE SHOULD CONSIDER RETIRING TO LIMIT DISUNITY IN THE
INSTITUTION. WHILE GARCIA WAS AWARE OF DISSENT TOWARDS HIM THROUGH-
OUT THE ARMED FORCES, HE AND FLORES LIMA WERE SURPRISED BY THE
EXTENT OF SYMPATHY WITHIN THE AIR FORCE FOR OCHOA'S POSITION.
PRESSURE IS BUILDING FOR GARCIA TO RESIGN AND, AS OF THE
AFTERNOON OF 10 JANUARY, THE FOLLOWING COMMANDERS CONTINUE TO

LTC. DOMINGO ((MONTERROSA)) BARRIOS, COMMANDER OF THE
ATLACATL BATTALION;
LTC. MIGUEL ANTONIO ((MENDEZ)), COMMANDER OF THE
RAMON BELLOSO BATTALION.

3. ALL KEY FIELD COMMANDERS AGREED THAT IN THE INTERESTS OF
INSTITUTIONAL DISCIPLINE AND COMMAND INTEGRITY, OCHOA MUST
BE TRANSFERRED TO AN OVERSEAS ASSIGNMENT, ALTHOUGH NOT NECESSARILY
AS MILITARY ATTACHE TO URUGUAY, AS ORIGINALLY ORDERED BY GARCIA.
GARCIA HAS SCHEDULED ANOTHER MEETING OF FIELD COMMANDERS TO
BEGIN AT 0900 HOURS ON 11 JANUARY. ARRANGEMENTS ARE BEING MADE

4. VIDES CASANOVA CURRENTLY IS THE MOST LIKELY CANDIDATE TO REPLACE GARCIA. IN THIS CASE, FLORES LIMA SAID HE WOULD BE WILLING TO REMAIN AS CHIEF OF STAFF BUT WOULD LEAVE THE ARMY IF BUSTILLO OR BLANDON, WHO HAVE BEEN MENTIONED AS POSSIBLE REPLACEMENTS, WERE APPOINTED. FLORES LIMA SAID HIS POSITION IN THE ARMY IS SOLID AND RECENTLY THERE HAVE BEEN EXPRESSIONS OF RESPECT AND SUPPORT FOR HIM FROM VARIOUS OFFICERS, INCLUDING MAJOR LUIS ROBERTO ((RODRIGUEZ)) SOSA, EXECUTIVE OFFICER OF THE SECOND MILITARY DETACHMENT IN CABANAS. IN AN ATTEMPT TO IMPROVE MILITARY PERFORMANCE AND IN RESPONSE TO THE COMPLAINTS OF NUMEROUS OFFICERS, FLORES LIMA INCLUDED ON HIS DRAFT OF THE ORDER TRANSFERRING OCHOA, THE REASSIGNMENT OF THE FOLLOWING INCOMPETENT OFFICERS WHO ARE GARCIA SUPPORTERS, TO NON-COMMAND POSITIONS:

COL. MARIO ADALBERTO ((REYES)) MENA, COMMANDER OF SANTA ANA DEPARTMENT;

COL. RAMON ANTONIO ((MORALES)) RUIZ, COMMANDER OF LA UNION DEPARTMENT;

COL. ROBERTO DE JESUS ((MONTERROSA)) BONILLA, COMMANDER OF THE NATIONAL NAVY;

COL. NAPOLEON ((ALVARADO)), COMMANDER OF SAN VICENTE DEPARTMENT;

COL. ELMER ((ARAUJO)) GONZALEZ, COMMANDER OF SONSONATE DEPARTMENT.

COMMENT: GARCIA REFUSED TO TRANSFER THESE OFFICERS BECAUSE OF THEIR PERSONAL LOYALTY TO HIM. HAD HE DONE SO, THIS WOULD HAVE BALANCED THE ORDER TRANSFERRING OCHOA AND WOULD HAVE BEEN MORE ACCEPTABLE TO GARCIA'S OPPONENTS.)
