TEXT: 1. DURING HIS 18-23 JANUARY 1985 VISIT TO EL SALVADOR, EDEN ((PASTORA)) GOMEZ, LEADER OF THE SANDINO REVOLUTIONARY FRONT (FRS), RECEIVED US \$3,140 AND PLEDGES FOR GREATER SUPPORT IN THE FUTURE FROM SALVADORAN MILITARY, PRIVATE ENTERPRISE, AND GOVERNMENT CIVILIAN REPRESENTATIVES. THIS MONEY ALLOWED HIM TO BEGIN HIS MUCH PUBLICIZED MULTI-NATIONAL FUND RAISING TRIP WITH THE FIRST STOPS IN MIAMI AND WASHINGTON. PASTORA PLANS TO COMPLETE THIS TRIP AND RETURN TO SAN SALVADOR ABOUT 1 FEBRUARY.

ON 22 JANUARY PASTORA MET WITH THE COMMANDER OF THE SALVADORAN NAVY, COLONEL HUMBERTO ((VILLALTA)); COLONEL SIGFREDO ((OCHOA)) PEREZ, COMMANDER OF THE FOURTH BRIGADE; ROBERTO ((D'AUBUISSON)), LEADER OF THE RIGHT WING NATIONALIST REPUBLICAN ALLIANCE (ARENA) PARTY, AND THE PARAGUAYAN AMBASSADOR, LLANES. THE REASON FOR THE MEETING WAS TO CELEBRATE PASTORA'S 48TH BIRTHDAY, BUT SUBSTANTIVE ISSUES WERE ALSO DISCUSSED.

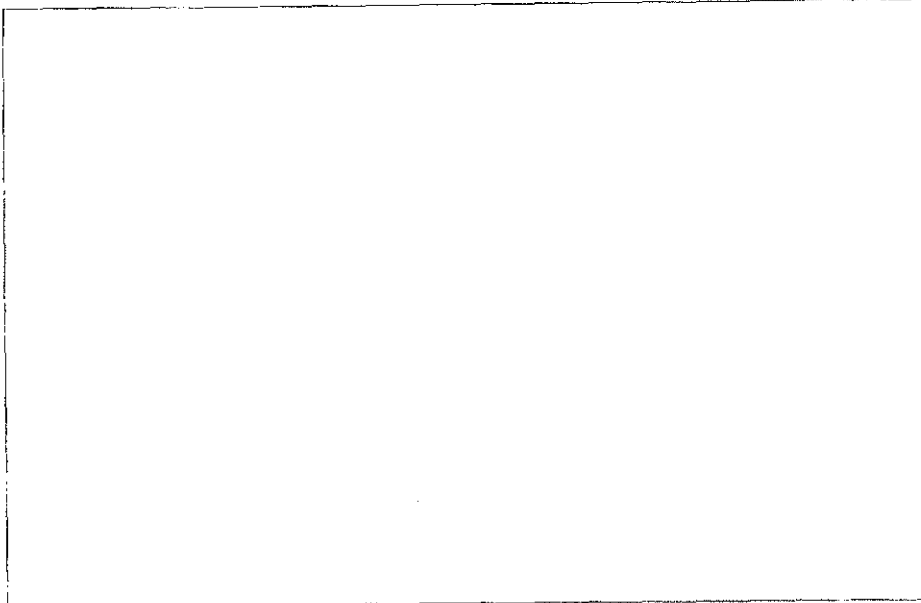
