1. (U) "LA PRENSA GRAFICA" MARCH 26 CARRIED A SALVADORAN
ARMED FORCES DENIAL OF WHAT WAS TERMED THE "SUPPOSED

MASSACRE" ACROSS THE RIO LEMPA FRONTIER IN HONDURAS. THE
DENIAL CRITICIZED BY NAME THE SAN DIEGO UNION JOURNALIST WHO
PUBLISHED THE STORY.

2. (U) THE DENIAL WENT ON TO SUGGEST THAT "MANY FOREIGN
JOURNALISTS DECEIVE THEIR READERS, RADIO LISTENERS AND
