This letter is to confirm my agreement with the production of a documentary film featuring the Phnom Penh Post newspaper and its staff as a vehicle to examine a number of issues relating to the current situation in Cambodia.

As I understand it, the film will involve eight weeks of filming starting in late August or September.


My staff and I agree to be involved and co-operate with the filming with two conditions:

1. We must see the film before lock-off so that we can comment on any issues which may effect the financial or political welfare of the Post or any of its staff. While we understand that editorial control rests with Film Australia, we have made it clear that there are a variety of sensitivities here in Cambodia with regard to the existence of the Post. In this regard, if the Post deems it necessary, we will be able to insist that certain clips be removed from the film should they endanger the existence/safety of either the Post or any of its staff. This is in recognition of the fact that journalism is a dangerous profession in Cambodia and we must take appropriate steps, as we do in publishing the paper itself, to minimize risk to the paper and its staff.


2) The film crew will be guided by myself and the staff as to any occasion when the film crew's presence will adversely effect the paper and the work of its journalists.

In return we will cooperate with you in any way necessary with the shared intention of making a first class film.

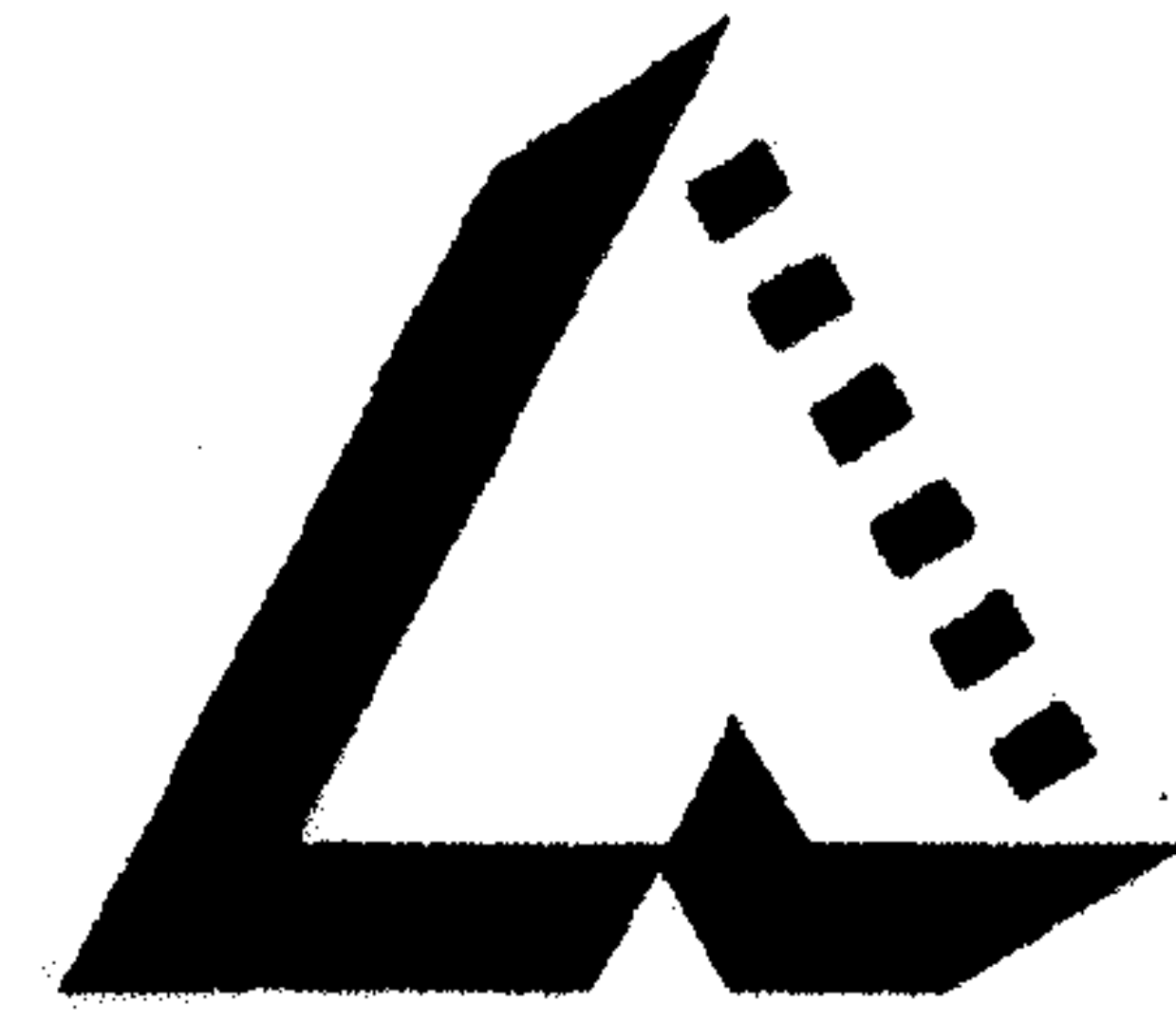
