PLAN FOR INVESTIGATING THE RECENT SECURITY PROBLEMS WHICH THE ORGANIZATION HAS ENCOUNTERED: 21 JULY 1983

1. Investigation into the capture of OTTO:

- a) Investigation into the work which Otto was carrying out during the time he was in the Eastern zone and its later repercussions on his downfall.
- b) Investigation into the work which Otto was doing during the time he was in CONAMAS and CONAPRO, how he carried it out and his observations, in CONAMAS, what were the later repercussions of the fall of Otto.
- c) Study of the political militancy of Otto in the organization, developing a complete file.
- d) Detailed investigation of the two comrades who accompanied Otto when he was arrested by the enemy.
- e) Detailed investigation of what were the last moments of Otto in CONAMAS and CONAPRO in various aspects: work, relatives, security measures, etc.
- f) Investigation in all details, who knew of the contact where Otto was captured and how the capture came to be made.
- g) Investigation in all details necessary, into how the two places in CONAPRO were situated after the capture of Otto and before the CIR was captured.
- h) Investigate and study the measures which CONAPRO took after the capture of Otto and the locations of his two working sites.
- i) Study what problems or indications had been given in the premises of the CIR before the fall of Otto, and what was the outcome of each of them.
- j) Investigate and make out a list of all whom they knew in the CIR headquarters and study the situation if necessary.
- k) Analyze all the information which the different sources give on the subject.

2. With regard to the capture of Bernardo, investigate:

- a) His behavior with the Organization in the final days.
- b) What security measures he was applying.
- c) Investigate all information possible to dig up on the family of Paula Pike.
- d) Investigate and study in detail Paula Pike: her political participation, etc.

- e) Investigate what the repercussions were and are now following the capture of Bernardo.
- f) Investigate everything known about Bernardo.
- g) What measures have been taken with regard to what Bernardo knows, and what effect they have had.
- h) Study all the versions on why Bernardo was captured, in accordance with the information which is obtained by the different sources.
- i) Study what were the conditions of the house where Bernardo was captured and why he went to that location.

3. In order to carry out all this work, I propose:

- a) To interview the members of the CO-CEN who were at the front or connected with these areas of work in which the comrades Otto and Bernardo were doing their tasks.
- b) Interview the comrades deemed necessary who are members of the organization where Otto and Bernardo were active.
- c) Interview all the comrades who, according to the reports which are surfacing, were implicated and who are believed to be able to help in clarifying the situation.
- d) Interview the two comrades who were accompanying Otto in the contact where he was captured.
- f) Interrogate the woman comrade who was captured by the enemy during the armed confrontation in the CIR headquarters.
- g) Another comrade would be authorized to collaborate with me in the work during its development, at least to help me in making fair copies of the material, although I would handle the interviews and all the more delicate things, if no one else, I propose that Comrade Emilio work with me on this job, the second in command of the Security Commission.

Comrade Marcial, if there is anything I have failed to specify in this plan, I think you will have to come out as the measures previously discussed develop, and I think that we will carry them on with the close coordination which we maintain for quick orientation. In hopes of your contribution, suggestions, etc. for getting this assigned work underway.

Whenever you notify me I will send the contacts for each comrade to interview and in this way I will begin to implement this plan.

Comrade Marcial: Commander in Chief of the Popular Armed Forces of Liberation, I wish you good health so that with all the dynamisms which you have, you may lead us on to victory.
